KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Jack Payne is the owner of that real property situated in the County of Mesa, State of Colorado, and lying within the E² of Section 35, Township 1 North, Range 1 West of the Ute Meridian, being more particularly described as follows: Beginning at the E⁴ corner of said Section 35; thence S00°11'10"W along the east line of said Section 35 439.72 ft; thence N89°40'06"W 775.37 ft; thence N00°11'10"E 1134.64 ft. to the south right-of-way of Interstate Highway 70; thence along said right-of-way with the following calls: (S88°20'35"E 257.41 ft; thence S79°48'35"E 202.20 ft; thence S88°20'35"E 319.01 ft.) to the east line of said Section 35; thence S00°11'05"W along said east line 646.97 ft. to the POINT OF BEGINNING; and containing 19.749 acres, more or less, as shown by the accompanying plat thereof:

That the said owner has caused the said real property to be laid out and surveyed as COUNTRY CLUB HEIGHTS, a subdivision of a part of the County of Mesa:

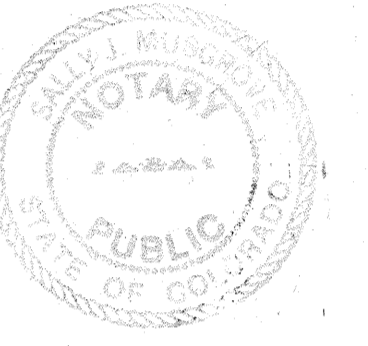

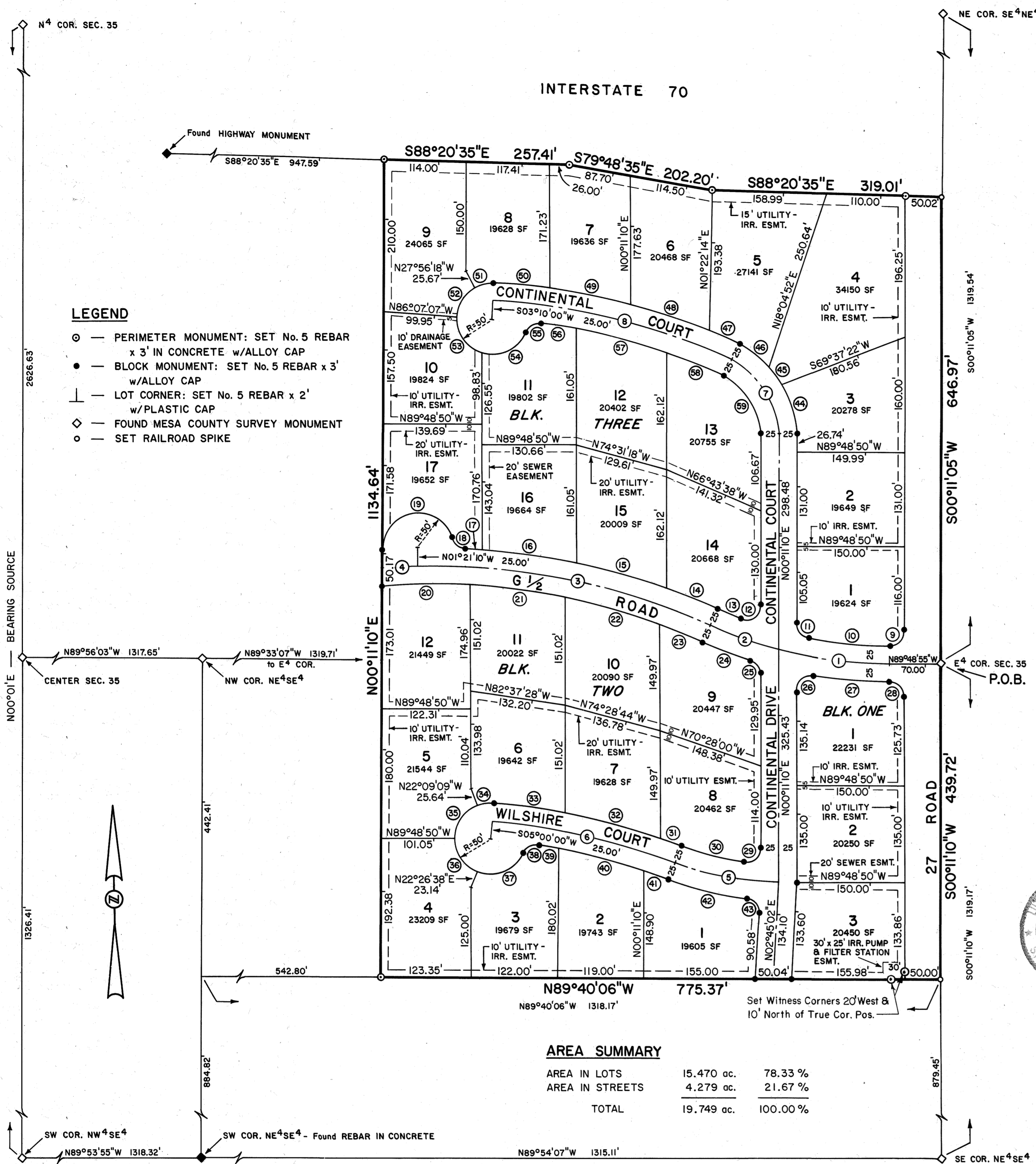
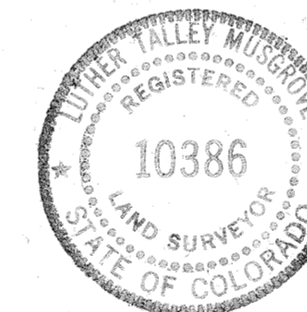
